Training recipients

The course is addressed to people responsible for deploying and updating operational system updates, managing both physical and mobile devices, regardless the owner with consideration of BYOD trend, for managing and navigating modern environment including mobile phones, tablets and computers, in spite of the fact whether they belong to organization or private employees including protection of data to which the devices have access to.

The course covers such topics as:

Planning and implementing strategy of deploying operational system and various available methods and scenarios, appropriate for particular environment, as well as how to deploy Windows system with the use of modern methods including planning and implementing Windows system update strategy

Key components of modern management and co-management strategies, including Microsoft Intune deployment in organization, as well as how to use it to manage modern computers and devices, that is methods of deploying and implementing browser applications

Key security concepts in management, including identity authentication and access, as well as information about how to protect these categories not to Azure Active Directory service, the use of Microsoft Intune to protect the device and data with the appliance of compatibility rules and key functions of Azure Information Protection service and advanced Windows Defender anti-threat protection, as well as ways to deploy these functions
